Parcel Division Application & Meeting \$500.00 for regular, \$825 for a "special" meeting

Planning Commission Hearing \$1,000.00 for Special Uses and Re-zones, Site Plan Review

Development Plans: \$1,100.00 plus the total cost for the Board – May require Escrow Agreement

Waterfront Greenbelt Plan Review Application \$250.00
