- 1) Call to Order:** The meeting was called to order at 7:00 P.M. with the Pledge of Allegiance at the Eveline Township Hall by Chairman McGinn.

- 2) Agenda:** Commissioner Sims made a motion to accept the agenda with addition of Jeff Dean as item 4. Motion supported by Commissioner Beishlag. Motion carried.
- 3) Minutes – September 4, 2024:** Commissioner Sims made a motion to approve the September 4, 2024 minutes as presented. Motion supported by Commissioner Beishlag. Motion approved.
- 4) Jeff Dean Deed Issue:** 9.3-acre parcel deed allows 3 other residents lakefront access right of way.
